The minutes of Harberton Parish Council meeting held on Tuesday 8th November 2011 at Harbertonford Primary School at 7.30.pm.

The Chairman opened the meeting by welcoming everyone, then he invited P.C. Addelsee to speak. He reported on one crime in the area for October – Driving or attempt with excess alcohol in the body. He then went on to report the surveillance of the speeding along the A381 in Harbertonford which was still ongoing, also complaints of speeding in Old Road. There was also a problem with parked cars at the junction by the bridge with Old Road/A381 during hours of darkness. After further discussions he and Sgt. Craxford both left the meeting.

C.Cllr. Black then gave her report. The A381 Interactive Lights were to be installed the following day – 9.11.11. In Totnes children's places in the schools were being discussed, there should be enough places for all the local children. She had also attended a Towns Women's Guild meeting, Totnes On the Move, S. Devon Waste Partnership. Cllr. Black then had to leave the meeting.

D. Cllr. Steer then gave his report. TOR Homes & D&C Housing Trust had amalgamated. The Sherford development was now being discussed again. A 33 housing development had now been started in Avonwick. At Tigley the enforcement had also started including various other developments on that site.

Cllr. Hutchinson had sent in a letter of resignation which the Chairman read out. After serving on the Parish Council for about nine years she felt it was the right time to go. The Playground on which she had worked so hard was now completed and she would continue with looking after it for the next five years. All present at the meeting were saddened at this news, but wished her well for the future.

The minutes of the Parish Council meeting held on 10th October 2011 in Harberton Parish Hall at 8.00.p.m. were then considered and after one amendment were signed by the Chairman as a true record.

The minutes of the Planning meeting held on 20th October 2011 at Harbertonford Village Hall at 3.00.pm. were also considered and after two amendments were signed by the Chairman as a true record.

Councillors also agreed to contribute £100.- towards these kerb stones. Proposed by Cllr. Janes, seconded by Cllr. Hookway. All in Favour. The Clerk will write to Mrs. Harvey accordingly.
