The minutes of Harberton Parish council meeting held on Tuesday 9th October 2012 at Harbertonford Primary School at 7.30.pm.

Present. Cllrs J. Hockings, Broom, Janes, S. Hockings, Hoddinott, Trott, Beamish, Camp, Padfield, Williams, Clayton, D. Cllr. Steer & C.Cllr. Black.

The Chairman opened the meeting, welcomed everyone and invited the public to speak. It was apparent they had all come to speak on the Luscombe Cross Turbines application 23/1990/12/F. There were some 14 or 15 speakers with varying views.

Cllr. Broom had declared an interest and left the room.

After some 40 minutes the public session closed and the special Planning Meeting commenced to consider 23/1990/12/F – Installation of 2 wind turbines (hub height 64m, tip height 99.5m) to generate 2.3mw per turbine, E of A381, S of Langridge Cross, Harberton. The Chairman urged the Councillors to think hard about this application which had been in the minds of all for some 2 years.

After a lengthy debate a proposal was made by Cllr. Hoddinott, seconded by Cllr. Williams to object to the application on grounds of nuisance to neighbouring properties and visual impact. Voting 5 in favour, 5 against. Another proposal was made by Cllr. S. Hockings to support the application in principle but ask SHDC to look carefully at the noise impact on the nearest properties, seconded by Cllr. Padfield. Voting 4 in favour. 6 against. Cllrs. Beamish and Clayton had concerns about users of A381 due to distraction caused by the turbines. Finally a proposal was made by Cllr. Camp, seconded by Cllr. Padfield. As the Parish Council was divided over the application, should SHDC approve this plan, the Parish Council would like any flooding and water runoff from the site to be addressed with light and noise nuisance also considered. Voting. 6. In favour, 3 against, 1 abstention. This Planning meeting closed at 9.25.p.m. and the members of the public left the hall.

At 9.30.pm. the monthly Parish council meeting commenced. Apologies from Cllr. Clayton.

Mr. Bryn Williams from the Environment agency then spoke. He had come to give details of the work now in progress at Palmers Dam, Woodland Road, Harbertonford. For the last week there had been upgrading and repairs taking place in spite of the heavy rains at the weekend and the dam overtopping for the second time this summer through excessive rains. This work would continue for a number of days yet. Also some undergrowth will be cleared from the banks of the Harbourne river this autumn. After some further discussions Mr. Williams and companion then left.

C. Cllr. Black then gave her report. The 'Car Free' day in Totnes had been a success. She congratulated the Environment Agency on their prompt attention to Palmers Dam repairs. There had been a Corporporate Scrutiny Spotlight at DCC. A Change to the Welfare System will be very much felt starting in November, particularly as women's pay was so low in the West country. Recycling had been reduced, more was being sold by Refurnish. D.Cllr. Steer then gave his report. Procurement Officers were working more with Teignbridge District Council to obtain better prices. A travellers site in the SHDC area had been proposed near Plymouth on land actually owned by Plymouth City Council . Plan 23/1941/12/F – Myrtle Cottage, Moreleigh Rd. Harbertonford had now been withdrawn.

Police Report received by email. 5 Crimes reported. 1 Burglary 5/6 Sept – Make off without payment 12.9.12. – Communications Act Offence 7.7.12. – Criminal damage to vehicle 14/15 Sept. – Theft between 1/8 and 24/9.

The minutes of the previous meeting were then considered and after one amendment were signed by the Chairman as a true record.

Matters Arising.

1. Neighbourhood Plan. Cllr. Broom reported that a formal letter of request had been sent to SHDC to carry out a

Plan for Harbertonford. This would take them about 6 weeks to consider.

2. It was reported that the problem oak tree at 7, Riverdale Harbertonford was not deemed to be dangerous.
