In the absence of Cllr. J. Hockings (Chairman) Cllr. Broom took the Chair. He opened the meeting and invited the speakers from Environment Agency to speak. Mrs. Fletcher –Peters had come to talk about setting up a Flood Scheme in the Parish, particularly in Harbertonford as several residents in Harberton had already got themselves organised. Mrs. Fletcher-Peters suggested that residents in Harbertonford, plus perhaps a couple of Cllrs. set up a sub-committee. She went through the possible flooding problems in Harbertonford and also mentioned the Flood Drop In evening at Follaton House, Totnes on Mon 17th Dec at 17.00-20.00h Also the fact that there were some grants available. After further discussions they then left the meeting. Several members of the public left their details with the Clerk to form a sub-committee

With the agreement of the meeting the Chairman then suggested they turn to Correspondence No.1 Parking in Old Road, Harbertonford. Mr. Sebastian Brown from Old Road then spoke all Councillors had received a copy of his proposals i.e. to make a parking area for Old Road residents at the top of the hill in Old Road above the School on Right hand side going up the hill in the existing pasture field. Following further discussions it was proposed by Cllr. Trott, seconded by Cllr. Beamish to approach the land owner's agent. Voting was carried. Mr. Brown then left the meeting.

Both County and District Cllrs had no reports.

The minutes of the previous meeting were then considered, agreed and signed by the Chairman as a true record.

- 1. Neighbourhood Plan.Cllr. Broom reported SHDC had now developed a protocol for this which will be discussed further at the next meeting. Both Totnes & Ugborough have approval.
- 2. Toll Housie Cycle Path. DCC are to evaluate and cost this project which is sponsored by Totnes on the Move.

The Parish Council regrets that earlier draft minutes which contained texts which mis-represented Councillors statements were released to a member of the public.

23/2675/12/F - 1, Angle Cottages, Harberton. 2 storey extension. No objections All in favour.

23/2775/12/F – Mill Meadow,. Harbertonford. Replacement of dwelling with two new dwellings. Proposed by Cllr. Padfield that there is a need to widen the footpath which becomes possible with this application. Seconded by Cllr. Trott.. Voting 4 in favour 5 against. It was proposed by Cllr. Williams to object as overdevelopment on height and width, seconded by Cllr..Janes including an amendment by Cllr. Padfield who then proposed to widen the footpath to allow safe passage for the increased population.

Voting on the second proposal 4 in favour, 3 against, 1 abstention.
