# Minutes of Harberton Parish Council meeting held on Tuesday 13 January 2009 at Harberton Parish Hall at 7.30pm.

The Chairman opened the meeting by welcoming everyone, then he invited County Cllr Date to give his report. Cllr. Date reported that he had attended several meetings recently, specifically one regarding providing grants for equipment for local playgrounds which will be decided soon. Several Parish Cllrs reported the road signing on Kingsbridge Hill going out of Totnes on A381 as dangerous and not clear enough during current road works. Cllr Date said he would look into the matter immediately. Cllr Hockings then raised the Langridge Cross drainage problem and after some discussion Cllr Date promised to follow this matter up also. This then led Cllr Hoddinott to mention the track at Ford Barn Cross, Harberton. This is opposite the road down from Langridge Cross which was breaking up, having been left unattended for many years. Cllr Hoddinott will enquire of DCC Highways on this matter. District Cllr Steer then gave his report. Firstly, SHDC will keep their Council Tax the same for the year 2009/10 with no increase in car parking charges either. There is a new free helpline available for financial advice with mortgages - 01392 686760. Last weekend
