Minutes of Harberton Parish Council meeting held on Tuesday 14 October 2008 at 7.30pm at Harberton Parish Hall.

**Present**: Cllrs Fearn, Knight, Hill, Jeffreys, Hoddinott, Hookway, Janes, Williams, Steer, Beamish, Hockings, Johnson & District Cllr Robert Steer.

Apologies: County Cllr Geoff Date.

Clerk: Mrs D Crann.

The Chairman opened the meeting, welcomed everyone and invited District Cllr Steer to give his report. He said on the walk he had led around the Diptford Areas on behalf of AONB, 10 people had attended. He had also been to a meeting on behalf of tenants of SHDC & TOR Homes. This was to introduce a new policy against Anti-Social Behaviour. SHDC had about £1.5 million invested in the Heritage Bank (a subsidiary of an Icelandic bank).

County Cllr Date had sent an email advising that he had nothing to report, but that DCC had no investments in any Icelandic banks.

Police – 2 reports this month.

- 1) PC Debbie Taylor had now retired from the Police.
- 2) 3 crimes recorded and detected in September. Also reports of an abusive door to door sales person to be aware of and an increase in fuel thefts everyone should be vigilant.

The minutes of the last meeting were then considered, agreed and signed by the Chairman as a true record.

# **Matters Arising:**

- 1) Street Lighting in Harberton. We are still awaiting DCC's report as promised. The Chairman reported 14 answers from Harberton residents of which only 1 was against reducing the lighting.
- **2)** Repair of fence at lower entrance to Harberton Playing Field ongoing.
- 3) Untidy state of pavement on inside edge

- outside 1 Mill Meadow, Harbertonford. DCC Highways reported to the Clerk that this was the responsibility of the landowner.
- 4) Re New interactive signs for the pedestrian crossing in Harbertonford across A381. The Clerk had just received a letter from Mr Halliday of DCC informing us this might be delayed until the end of the financial year.
- **5)** Re Harbertonford Football Club's request for a grant. A copy of their accounts had now been received and passed around the meeting. It was proposed by Cllr Williams, seconded by Cllr Beamish to grant £250.00 towards a new gas boiler to heat the showers. There being no other proposals, voting was all in favour.
- **6)** Cllr Hill reported that a tree surgeon had examined a reported dangerous tree along Bow Rd. Harbertonford in his hedge and had passed it OK.
- **7)** Cllr Jeffreys reported further new additional items at the Harbertonford Playground including new bow fencing alongside part of the footpath.
- 8) Re Mrs Ganter's comments on the deteriorating state of Church Cottage in Harberton, the Clerk was now able to report that there was to be a new gate and that the brambles in the garden were to be cleared away.
- 9) Monkey Oak, Harberton. DCC Highways will to look into the request for 'No Through Road' signs entering the Green Lane leading to Englebourne.
