# 2. Approval of minutes from the last meeting.

The minutes of the meeting 07/04/15 were signed as an accurate record.

3. Report on actions from the minutes There were none.

# 4. Consider signatories for Community Benefit Fund bank account.

It was RESOLVED that all members of the Finance Committee and the Parish Clerk be signatories to the Community Benefit Fund bank account.

### 5. Receive budget report from the Clerk

Councillors received a report on expenditure to date. It was noted that the budget for 'Office Expenses' may have been under estimated and may need to be increased in the next year's budget.

#### 6. Clerk's annual appraisal

It was agreed that the Clerk and Chairman arrange a one-to-one meeting for appraisal.

# 7. Consider Parish Council response to Hazard Community Benefit enquiry

The Clerk reported that a resident of Hazard had been in touch to suggest the Community Benefit Fund contribute retrospectively to the cost of screening the solar development. Following discussion **it was RESOLVED** that the clerk write to the resident stating that all applications submitted to the Community Benefit Fund will be considered, but it was suggested that retrospective applications would be viewed cautiously.

### 8. Consider applications to the Community Benefit Fund

The Finance Committee considered two applications to the Community Benefit Fund received in the third round (deadline for applications 30th June 2015).

The Chairman declared an interest in the Totnes Caring application and did not participate in discussion. The chair was handed to the Vice Chairman during discussion.
