MINUTES of the Extraordinary General Meeting of Harberton Parish Council at 7:30pm on Tuesday 16th June 2020, by online and telephone conferencing.

- 3. To consider Tree Survey Report and quotation for works.

Parish Councillors had been forwarded the tree survey as produced by Dart Forest Tree Works which made recommendations on maintenance of trees at Harbertonford Playpark and Harberton Playing Field. **It was RESOLVED** to accept the report.

The report made the following recommendations:

Cllrs considered four quotes obtained to undertake recommended work.

It was RESOLVED to accept a quotation from South Hams Arborists for Safety work at Harberton Playing field, removal of deadwood from T0241 and large Oak tree, chipping and removal of all arisings, park left clean and tidy. Replacement rope for the rope swing, 15m in length, brand new climbing Rope at a cost of £339.75 (no VAT).

It was RESOLVED to accept a quotation from Tree Fellas for works at Harbertonford Play Park: Tree tag No 242. Reduce tagged south eastern stem by approx. 6-8m and reduce the remaining crowns of stems by 3-4m. Group of trees tag No 243. Reduce 2 Ash and 1 Sycamore trees down to 4-5 meters. Woodchip left in the undergrowth and the wood removed. Areas left neat and tidy at a cost of £885 plus VAT. It was agreed to request that any wood be removed via the school playground, and not via Riverdale.

It was noted that it would be required to break the padlock on the gates to the play area, and a replacement padlock provided. **ACTION: Clir Camp** to source tools to break the lock.

4. To consider payment of invoice for Tree Survey Report.

It was RESOLVED to pay invoice B611 from Dart Forest Tree Works for Tree Survey at Harberton and Harbertonford Parks at a cost of £435 plus £87 VAT = £522
